Data Center Rules

As a condition to the ongoing use of the Premises, all users must comply with the Special Rules set forth herein and as may be adopted or revised by IC2 HOLDINGS in its reasonable discretion from time to time. IC2 HOLDINGS reserves the right to make such other and reasonable Rules as, in its judgment, may from time to time be necessary or desirable. Participant agrees to abide by all Special Rules as stated herein and any additional rules and regulations, which are adopted.

Prohibited Materials

- food and drink
 - tobacco products
 - explosives and weapons
 - hazardous materials
 - alcohol, illegal drugs and other intoxicants
 - electro-magnetic devices which could unreasonably interfere with computer and telecommunications equipment
 - radioactive materials
1. Each person wishing to enter the Premises must be on the authorized user list. Positive proof of identity is required before initial entrance to the Premises is permitted or when such person signs up for a security access clearance.
 2. Each person wishing to enter the Premises must obtain a security access card from IC2 HOLDINGS in order to enter. This is anticipated to be a one-time process, per person.
 3. All activities in the Premises must be in compliance with the law including all applicable local, state, and federal laws, rules, codes and regulations.

Data Center Rules

4. All cross-connects must be accomplished by IC2 Holdings technicians. Cross-connects shall be charged at the following rates:
Copper-\$25monthly
Coaxial-\$50 monthly
Fiber-\$100 monthly
Cross connects between the same Customer contiguous cabinets, racks, or cages must be completed by IC2 Holdings and may be provided at no charge as negotiated on the Service Order requesting service.
5. The Premises must be kept clean and free of debris at all times.
6. On a best-efforts basis, participants agree to be efficient in the use of premise resources including use of power and equipment. Lights are to be turned off when leaving the data center. Circuits supplied from the UPS are to be allocated efficiently and, to the extent practical, such as to maximize use of available power in each circuit before activating another circuit to prevent or minimize allocation of circuits, which are only for standby use and are not actually used for supplying ongoing power.
7. No Photographic or recording equipment of any kind (other than tape back-up equipment) without IC2NET approval.
8. No storing of any paper products or other combustible materials of any kind in the Customer Area (other than equipment manuals)
9. If customer requires the removal of any equipment from their cabinet/cage they must request an equipment removal pass from a member of the IC2NET Data Center Team, which shall not be unreasonably withheld. Permission may be granted in writing or verbally. This rule is to protect the potential removal of hardware without the knowledge or approval of our customers; in an effort to protect the security of our Data Center. If customer removes hardware without consent from IC2NET they may lose un-escorted access privileges.
